**05. Activity not previously reported to the IRS (Part V, line 33)**

After temporarily suspending programming in 2022, in 2023 we restarted several programs that had been in operation prior to Covid. These included a cemetery tour in October (2 nights, 20 attendees per night \$15 admission per attendee) and a mine hike. We also began working with students at a local high school to design a new exhibit for Gilman Town Hall, one of our museums. Finally, while the Issaquah trolley did not resume service, a group of 4-5 volunteers plus our Executive Director performed regular maintenance on the trolley and tracks and conducted a feasibility study to explore reopening trolley service in the future.

**06. Part III, response or note to any other line in Part III**

MISSION: To discover, preserve, and share history and heritage of Issaquah and surrounding area.

ACHIEVEMENTS: Collections - Cared for the roughly 40,000 items in our collection, including physical artifacts, documents, maps, photographs, and more representing Issaquah history. Processed new gifts into our collection and maintained two online catalogs and library reference material in support of historical research.

Mine Hike - On one day in October, a volunteer led a group of participants on a hiking tour of several Issaquah mines, telling the mining history of the region through this interactive tour.

Trolley storage, maintenance, and feasibility study - In 2023 volunteers inspected the trolley and performed necessary maintenance and repairs. Our Executive Director led a work group who worked with the city to determine logistics required to restart operation of the trolley.

Cemetery Hikes - During the weekend in late October, 4 volunteers plus our Executive Director led over 40 participants on a tour of the Hillside Cemetery in Issaquah, telling the history of Issaquah through the stories of some of the residents buried there.

Operations - In March, engaged a new Executive Director, Paul Winterstein, who immediately developed a comprehensive work plan in collaboration with the board, staff, and volunteers.
